US Imposes Economic Sanctions Against Turkish Companies for Dealing with Russia

The United States is part of an international coalition, including the G7, the European Union, the United Kingdom, and Australia, that have imposed economic sanctions against Russia for Russia's invasion of Ukraine. Turkey has not imposed and does not maintain sanctions against Russia. Turkey trades freely with Russia and undermines the US sanctions against Russia.

Under the US sanctions regime, sanctions have been imposed against governmental and commercial entities in Russia (the "Russian Targets"). In an effort to prevent Turkish companies from helping the Russian Targets evade sanctions and from supporting Moscow in its war against Ukraine, the US has also imposed sanctions against several Turkish companies which equates them to Russian Targets. This has been done through the US government's designation of these companies as Specially Designated National of Russia ("SDNs") and publication of their SDN status. The principle at work in this regard is, "the friend of my enemy is my enemy."

Consequences of Designation as an SDN

As a result of your company's designation as an SDN:

All transactions of your company with or involving the United States or US persons are prohibited, unless authorized by the US Treasury Department;

All property, including assets and funds of your company in the United States or within the possession or control of a US person are blocked or frozen. This includes funds in US funds transfers remitted by or coming to your company;

As a practical matter, all banks and other entities around the world will hesitate or refuse to deal with your company for fear that they may themselves be designated as an SDN for doing so; and

Your company will suffer reputational and credit damage.
